South East quarter of Section 19-3-1E containing 159-70/100 acres of land

directed to be sold at Huntsville in Pursuance of the Laws providing for the sale of the lands of the United States in Mississippi and Alabama. There is granted by the United States unto the said ALLEN CHRISTIAN and . LEMUEL MEAD the quarter lot or Section of Land above described. To have and to hold the said quarter lot or section of Land, with the appurtenances until the said ALLEN CHRISTIAN and LEMUEL MEAD, their heirs and assigns forever as Tenants in Common and not as joint tenants.

Allen Christian and wife [Margaret]

This Indenture made this 7th day of April, 1835 between ALLEN CHRISTIAN and MARGARET, his wife, of the one part and LEMUEL MEAD of the other part, all of Madison County, State of Alabama.

Witnesseth that the said parties, Allen Christian and Lemuel Mead, being tenants in common of the South East quarter of Section nineteen in Township three of Range one East of the Basis Meridian [SE/4 Sec. 19-3-1E] in said County and wishing to make partition of said quarter Section, have agreed, surveyed and divided the same into two equal parts as to quantity by lines

beginning at a (Stone) stake seven chains and twenty five links [7c 25 L] north of the South East corner of said Section, thence running South sixty three and half degrees west [S-63-1/20 W] eleven chains and eighty links to the South west corner of a Stone Spring house (belonging to said Mead) thence along the Spring branch North fourteen degrees west [140 W] about one chain to the head of said Spring near said Spring House wherever the same may be so as to divide the Spring and branch near the spring equally, the same remaining in common between the parties with all the privileges and rights of egress and regress to said Spring for watering &c - thence by a line running North fifteen degrees and forty minutes west twenty eight chains and seventy five links [N 150 40 W 28c 75 L] to a Stake in the half section line, twelve chains and seventy links [12c 70 L] from the north west corner and twenty seven chains thirty links [27c 30L] from the North East corner of said quarter Section, making Seventy Nine acres and eighty hundredths [79-80/100] to each division and by agreement of the parties that moity or half of said quarter section lying South and West of said dividing line is allotted and partitioned to said Allen Christian and the moity or half of said quarter Section lying north and East of said dividing line is allotted to said Lemuel Mead.

Wherefore the said Allen Christian and Margaret, his wife, for and in consideration of the premises and of the sum of one Dollar to them in hand paid by the said Lemuel Mead, the receipt whereof is hereby acknowledged, have bargained and sold, and by these presents do bargain and sell unto the said Lemuel Mead, his heirs and assigns, all the right, title, interest, and claim which the said Allen Christian and wife have of, in, and to all of that moity of said quarter Section of land numbered nineteen in Township three, Range one East [Sec. 19-3-1E] lying or being on the north and east of said dividing line according to said agreement, the partition containing seventy nine acres and eighty hundredths of an acre [79-80/100], to have and to hold the said Moity or half quarter Section of Land to allotted and divided as aforesaid with the tenements and appurtenances, rights, privileges and uses aforesaid unto the said Lemuel Mead, his heirs and assigns forever,

This indenture made this 7th day of April, 1835 between Lemuel Mead and Martha, his wife, of the one part and Allen Christian of the other part, all of Madison County in the State of Alabama, Witnesseth:

That the said parties, Lemuel Mead and Allen Christian, being Tenants in common of the SE/4 of Section 19-3-1E of the Basis Meridian in said County, and wishing to make partition of said quarter section have agreed, surveyed, and divided the same unto two equal parts as to quantity by lines

beginning at a (Stone) stake 7 chains 25 links north of the South East corner of said Section, thence running South 63-1/20 West 15 chains & 80 links to a Lombardy poplar, thence North 24° West 11 chains & 80 links to the South West corner of a Stone Spring house (belonging to said Mead) thence along the Spring Branch north 140 west about one chain to the head of said Spring (near said Spring house) wherever the same may be so as to divide the Spring and branch near the Spring equally, the same remaining in common between the parties with all the privileges and rights of egress and regress to said spring for watering & etc.
