Now in consideration of the premises and for the further consideration of Five Dollars [\$5.00] to the said Sarah in hand paid by Allen Christian [Jr.], the receipt whereof is hereby acknowledged, she the said Sarah hath this day bargained, sold and conveyed and by these presents doth bargain, sell and convey to the said Allen Christian, two Negroes to wit:

Eliza, a negro woman about twenty years old, and Ermin[?], a girl about four years old; also a bed and furniture and all her interest in the Estate of her father, Allen Christian [Sr.], Deceased, whether the same be real or personal property,

In trust, nonetheless, that said property shall be held by the said Allen Christian [Jr.] for the use and support of the said Sarah and not for the use or benefit of the said Littleberry Wade, and if the said Sarah should die without bearing issue, then said property both real and personal, to belong exclusively to the said Allen Christian for his own use and benefit. And the said Littleberry Wade doth hereby assent to the provisions of the foregoing Deed.
